

WINUTES OF THE ANNUAL GENERAL MEETING OF MEMBERS VJH Medical Staff Association and

Vernon Jubilee Hospital Physician Society

(the "Society")

Held IN-PERSON Tuesday, October 8, 2024

PRESENT: 28 physicians in attendance – quorum not met.

1. Call to Order and Welcome

The Annual General Meeting of the VJH Medical Staff Association and the Members of the Society was convened at 6:35 PM by Dr. Jason Doyle, President of the Society's Executive Committee, who acted as Chair of the meeting.

1.1 Land Acknowledgement

Acknowledgement with gratitude that the meeting was held on the traditional, unceded territory of the Okanagan Sylix people.

1.2 Quorum

As per the Medical Staff Association by-laws, a quorum of 25% (32 Active status members) is required for a meeting to proceed. If 32 members were not present by **7:00 PM**, motions would be emailed to all physicians not in attendance. **Dr. Doyle requested that T. Blake monitor attendees as they arrived and to advise when 32 Active members were present.**

2. Opening Remarks and Formalities

2.1 Appointment of Secretary

3.2 MSA Year in Review Highlights

Special thanks to Doctors Jenny Smith and Shannon Rourke for leading the social committee.

In the spring the Physician Society hosted a strategic planning dinner for any MSA physician who wished to attend. The feedback received at that meeting has formed the basis for activities and initiatives this year.

Last year the number of GMS meetings was reduced from four to two. Dr. Doyle welcomed feedback as to whether the number of GMS meetings should be increased.

Discussion followed regarding ways to increase physician engagement. Dr. Cunningham suggested three open seats be reserved for anyone who wishes to attend a working group meeting. It would give people interested in joining the Working Group or Executive to see what is being done. It would also allow issues to be brought forward by people not formally on the committee. Favorable consensus around one GMS meeting focusing on strategic planning.
